

## **Eaton's B-Line Business Freight Terms Policy Addendum (U.S.)**

**Effective March 1, 2018**

This addendum references Eaton's B-Line Business' Freight Terms Policy as follows:

Freight will be prepaid and allowed by Eaton's B-Line Business according to the following values below, per product line.

\* When combining products from any of the product lines shown for eligibility for combined freight, shaded product lines are not eligible and are subject to the dollar amounts listed above as standard terms.

Freight terms are FCA Origin and standard service, with title passing to customer as soon as the product is passed to the carrier, or leaves Eaton's shipping dock.

Multiple releases for single orders must be approved by Eaton's B-Line Business. For non-qualifying orders, Eaton reserves the right to prepay and add charges to the invoice, unless specified by the customer at time of order submission. If the customer is requesting collect or third party billing, the following information is required on the order: payer name and address, carrier name, phone number and account number if applicable.

For shipments outside of the 48 contiguous United States of America, contact Eaton's B-Line Business for additional terms and conditions that may apply.

Partial shipments will be made at the discretion of the customer, provided the customer pays the excess freight. When Eaton's B-Line Business bears the cost of shipment, we reserve the right to ship all orders in one complete shipment using our carrier of choice. Partial shipments may be made at the discretion of Eaton's B-Line Business.

B-Line reserves the right to apply additional charges as shown for services requested by the customer.

- Beyond Charge - \$150
- Lift Gate - \$50
- Redelivery Fee - \$75
- Re-consignment (incl. Mark and Tag) - \$75 (plus freight charges)
- Sat/Sun/Holiday delivery - \$100
- Residential Delivery - \$50
- LTL Timed Delivery (appointed time) - \$85
- Truckload Detention (per hour after 2 free hours) - \$60
- Truckload Layover (driver has to wait overnight) - \$300
- Truck ordered not used (cancellation) - \$300
- Tarp Request - \$75
- Skeleton Crating - 15% Sales Order Value
- Full Crating - 25% Sales Order Value
